

Appendix 3) Synopsis of documents included in CALD  
- ordered by type per century -  
(Not for publication)

This synopsis orders the metadata of legal documents by type (T: left column) and century. Legal documents in the sense of Islamic law (T=4\*) are distinguished from others (T is not 4\*).

Within each line (one type per century), the numbers of complete and fragmentary documents are indicated. The column “image uploaded” refers to photos of these documents in CALD. The column “published” indicates the amount of published documents, the column “CALD ‘done’” when the full Arabic text is inputted.

NB: The numbers apply for January 2014 and have only indicative value. Mathematical inconsistencies may be due to missing or erroneous data-input.
